

## **BIDDERS NUMBERS REQUIRED**

Please Register With Sales Office

### **To register you will need to present:**

1. Picture ID such as driver's license.
2. Provide payment and bank information.
3. New Buyers paying with personal or business checks MUST PROVIDE a letter of guarantee or a letter of introduction from their bank at the time of registration for a Bidder's Number.

### **All accounts MUST BE PAID during or immediately following The end of the sale.**

All payments shall be in U.S. CURRENCY or checks drawn on U. S. Banks ONLY. Method of Payment shall be Cash, Cashier's or Certified Check. Personal check (with proper bank letter of introduction and picture identification, such as driver's license. Traveler's Checks or Credit Cards (Master Card, Visa or American Express).

### **ALL SALES FINAL**

Buyer's Premium 3% is discounted for purchases paid by check or cash.

To obtain Original Registration Certificate at the sale, payments must be made by Cash, Certified Check or Money Order. Registration papers will be mailed to AQHA approximately 21 days after the sale for horses paid for by check or credit card.

All returned checks will be immediately turned over to the Country District Attorney's office. Cost of collection, including attorney's fees will be assessed to the buyer. In addition there is a \$50.00 charge for any returned checks.

## PROCEDURES FOR ABSENTEE BIDDERS

**Mail Bids:** Pre-register using the Absentee Bid Form. Be sure to sign the Absentee Bid Form. Use the Absentee bid form to state your bid and give the appropriate buyer and contact information. The deposit for mail bids and the Absentee Bid Form must be received by our office no later than noon on Friday, June 29, 2018. For mail bids, Alan Parker Auctions will bid on your behalf up to the specified amount. Any bid placed on your behalf would be one bid past the last bid from other bidders in the audience.

**Telephone Bids:** Pre-register using the Absentee Bid Form in this catalog. Use the Absentee Bid Form to give the appropriate buyer and contact information. You will be called one horse prior to the horse you intend to bid on.

**Deposit of Funds:** A deposit in the full amount of the bid price is required in the form of an Official Bank Check made payable to Alan Parker Auctions, LLC, or by Bank Wire Transfer. Bank wire instructions are available on request from Alan Parker Auctions, LLC office. The deposit for absentee bids must be made by no later than noon on Friday, June 29, 2018.

**Credit Cards will be accepted for Absentee Bids, with the full amount put on hold on the card by noon on Friday, JUNE 29, 2018. All Credit Card Purchases are FINAL.**

**Return of Funds:** If your bid is successful, any overage will be returned to you. If your bid is unsuccessful, your funds will be returned to you in the same form as sent to us.

Alan Parker Auctions, LLC will not be responsible for missed mail or phone connections or inability to contact the seller for any reason. The CONDITIONS OF SALE, as printed in the catalog, apply to all purchases.

**EXAMINE HORSES BEFORE BIDDING:** Veterinary assistance is available at bidder's expense on request to the sale company. Please be sure you have adequately examined all horses on which you intend to bid.

**ANNOUNCEMENTS:** To avoid making costly errors, please pay close attention to all announcements made from the auction stand, especially concerning horses on which you intend to bid.

**AGENT'S AUTHORIZATION:** Persons acting as agents must file an Agent's Authorization Form satisfactory to Alan Parker Auctions, LLC at least 12 hours prior to the sale session. They must indicate they are purchasing as an agent on the Acknowledgement of Purchase.

**ACKNOWLEDGEMENT OF PURCHASE:** After making the final bid on a horse, you will be asked to complete and sign the Acknowledgement of Purchase and Security Agreement Form. Be sure to confirm the correct hip number and price before you sign. Please print your name and address clearly, since this document is used for all registration transfers, invoicing, and any communications.

**STABLE RELEASE:** In order to remove a horse from the grounds, you must obtain a Stable Release from the Sale Office. Please confirm that the release you obtain represents the correct hip number. Also, be sure to give the release to the person ultimately responsible for removing your horse from the grounds.

**DO NOT REMOVE HIP NUMBERS FROM HORSES** before leaving the Sale Grounds.

**ALL SALES OR TRANSACTIONS FOR HORSES ENTERED IN THIS SALE MADE ON THE SALE GROUNDS MUST BE REPORTED TO AND MADE THROUGH THE SALE OFFICE.**

**HORSES REMAINING after that time** are left at the buyer's risk, responsibility and expense. Any delays in shipping of horses must be approved by the sales office. Horses being removed from the sale area must have sale hip number still visible and paid receipt from the sale office to present to a sale security guard.
